

# True Potential Pictet Growth

## Fund objective

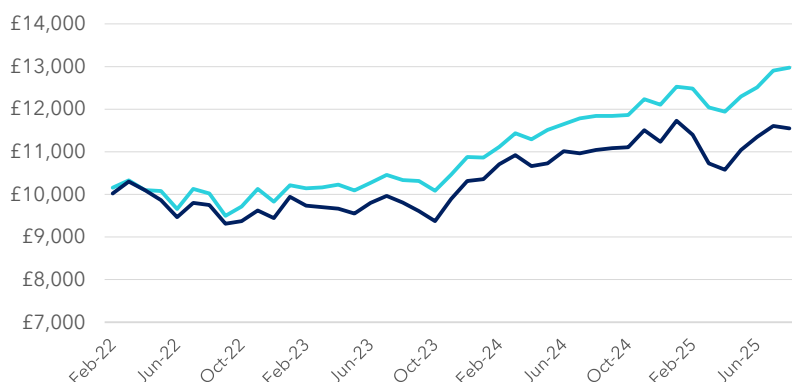
The Fund seeks to deliver growth over a rolling 3 year period net of fees.

## August Update

Risk assets delivered further gains in August, supported by rising expectations for an interest rate cut in the US and solid quarterly earnings. In developed markets, Japanese equities outperformed, while European and UK shares rose yet lagged global equities. In fixed income, Emerging Market (EM) debt led the gains, helped by a softer US dollar. In sovereigns, US Treasuries performed well while UK Gilts proved a laggard. Elsewhere, US high yield bonds outpaced their European counterparts.

The True Potential Pictet Growth Fund returned -0.47% (net of fees). The Fund's lower exposure to equities detracted, while the allocations to global thematic equity funds delivered mixed results. The exposures to the digital and robotics themes underperformed, but the high-dividend theme provided a notable positive contribution. The allocations to the Pictet Quest AI-Driven Global Equities and Pictet Quest Global Sustainable Equities portfolios were supportive, as was a modest exposure to European financials. Elsewhere, the allocation to EM shares did well, with Asian equities leading the gains. In fixed income, the Fund's allocation to UK Gilts proved the most notable detractor. Meanwhile, the allocation to US inflation-linked bonds was advantageous, along with the exposure to global high-yield bonds. Elsewhere, the Fund's holding in EM local-currency debt delivered the best gains within the segment. The allocation to commodities was advantageous with a notable contribution from gold. The Fund hedging most of the US dollar exposure back to sterling was also beneficial.

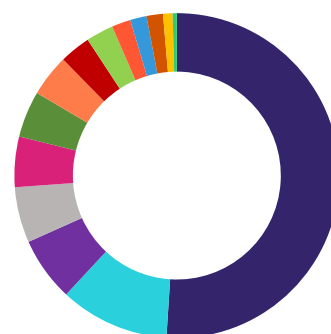
## What are the fees associated with investing in this fund?

The OCF of this fund is currently 0.84%. This means that if you invest £1000 in the fund, you can expect to pay £8.40 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
<b>Investment Fund Risk</b>	This Fund invests into other investment funds, they may invest in different assets, countries or economic sectors and therefore have different risk profiles not in line with those of this Fund.
